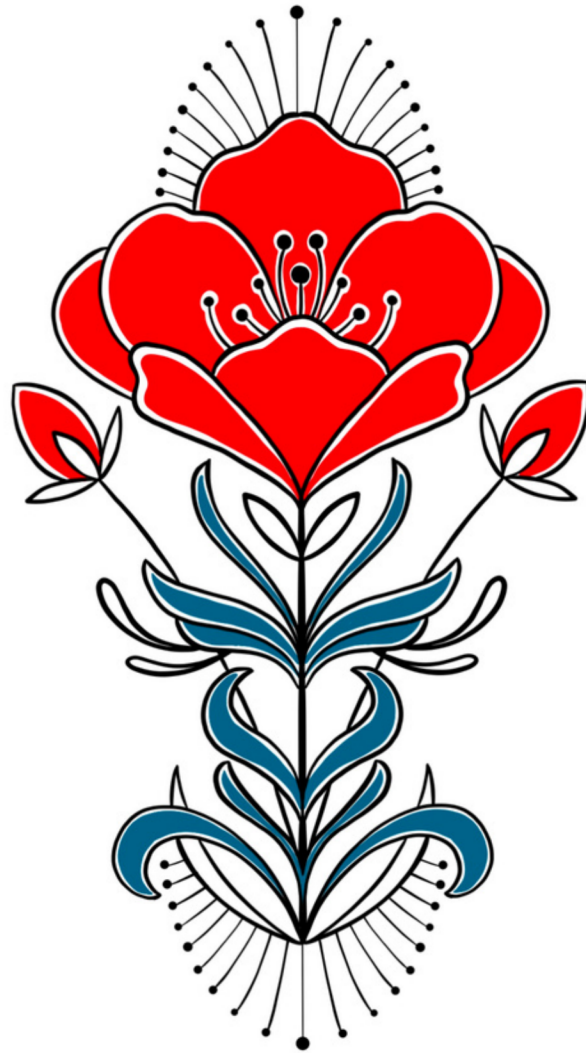

BRIDAL MAKEUP PACKAGES & RATES

THE ADORE ABROAD PACKAGE

The Adore Abroad Package includes makeup for the bride and up to three others on site within 1 hour and 45 minutes of Adore Rouge. The bride will also get a full-size lip touchup product and an in-studio trial run prior to the wedding where we will design your big day look.

Pricing starts at \$1,200.

THE DESTINATION PACKAGE

This package is for weddings taking place more than 1 hour and 45 minutes away from Adore Rouge. It includes travel, overnight accommodations for the artist, makeup for the bride and up to four others, as well as a full-size lip touchup product and an in-studio trial run for the bride.

Pricing starts at \$1,650.

ADDITIONAL ATTENDANTS

If you have more people in your party that would like to have makeup services, I can provide you with a custom quote upon request. but please note that I am currently only accepting parties of up to seven people.

THE ELOPEMENT & MICRO WEDDING PACKAGE

This package includes makeup for the bride and one other person within an hour of Adore Rouge and is limited to weddings taking place Monday thru Thursday. It also includes a full-size lip touchup product and an in-studio trial run for the bride.

FREQUENTLY ASKED QUESTIONS

HOW DO I RESERVE MY DATE?

Adore Rouge LLC requires a signed contract and 50% non-refundable deposit in order to reserve your date. In order to get your contract together I will need to know how many people will be getting makeup services and an estimate of what time you'd like to be finished getting ready by. Please note that your date is not booked until a signed contract and deposit are received by Adore Rouge LLC. Once the contract has been sent to you a temporary hold will be placed on your date for three days to give you time to review and return it with a deposit. If your contract and deposit is not received during that time Adore Rouge LLC will be unable to guarantee your date and contract terms.

HOW DOES PAYMENT WORK?

You will be invoiced for the 50% deposit when the contract is sent out, and the remaining 50% will be due no later than ninety days prior to the wedding. An invoice for the final payment will be emailed to you a week before it is due unless requested otherwise.

CAN I ADD MORE PEOPLE AFTER THE CONTRACT HAS BEEN SIGNED?

I will try to be as accommodating as possible but please note that Adore Rouge LLC can only guarantee availability for the originally contracted number of people. If you need to change anything, please let me know as soon as possible so I can try to accommodate your needs.

CAN I HAVE MORE THAN ONE TRIAL APPOINTMENT?

A trial session of one hour and fifteen minutes is included with all of the bridal packages, however if you decide you want to try out additional looks you can schedule another appointment for a fee.

WHAT DO YOU NEED THE DAY OF THE WEDDING?

A parking space, access to an electrical outlet, and a surface to work off of like a table or dresser.

WHAT DO I NEED TO DO THE DAY OF THE WEDDING?

All you need to do is be in my chair an hour before you need to be finished getting ready with a clean, moisturized face. Please take care to remove all traces of makeup from the night before, and ask anyone in your party getting makeup to do the same.

WHAT DO I NEED TO KNOW ABOUT MY TRIAL APPOINTMENT?

All trials take place at Adore Rouge LLC, located at 306 Warren Ave, Unit 5A in Portland, ME. You reach my studio through a side entrance of the building so you will be contacted with specific directions when you book.

It is your responsibility to schedule your trial. Please do so in advance as I book up quickly and availability can become limited.

It is recommended that you have your trial no sooner than two to three months prior to your wedding day.

An hour and fifteen minutes is booked for your trial. Please arrive on time as I book other appointments and out of fairness for all of my clients I am not able to extend your appointment beyond what is scheduled. I have a ten minute grace period for lateness but after that will require that you reschedule so that we have enough time to complete your service and you get all the attention to detail you deserve. You will be responsible for booking and paying for an additional appointment if one is needed due to tardiness.

I'M GETTING MARRIED ON AN ISLAND, ANYTHING I SHOULD KNOW?

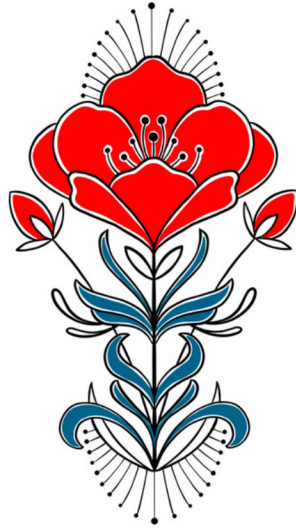
